

ORDINANCE NO. 2020-XX

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON,
BOONE COUNTY, INDIANA CONCERNING AMENDMENT TO CHAPTER 77 –
PARKING SCHEDULES**

WHEREAS, the City of Lebanon (the “City”) is a duly formed municipal corporation within the State of Indiana governed by its duly elected Mayor and Common Council (“Common Council”);

WHEREAS, pursuant to Indiana Code § 9-21-1-3(a)(1), the City of Lebanon, Indiana (“City”), within the reasonable exercise of its police power, may by ordinance regulate vehicular parking; and

WHEREAS, the City has previously regulated vehicular parking within its corporate limits, such regulations being codified, in part, in City Code of Ordinances, Chapter 77 – Schedule I;

WHEREAS, the Common Council of the City now finds that it is in the interests of public safety and welfare to further regulate parking on certain portions of City-owned public right-of-way.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon, Boone County, Indiana, meeting in regular session, as follows:

Section 1. The foregoing Recitals are incorporated herein by this reference.

Section 2. As of the effective date of this Ordinance, Chapter 77 – Schedule I of the City Code of Ordinances shall be amended to add the following:

- (DDD) On the Northerly side of Minerva Street south of the south line of Caraway Street;
- (EEE) On the North side of Caraway Street between the east line of Sam Ralston Road to the west line of Jean Court;
- (FFF) On the South side of Caraway Street between the east line of Sam Ralston Road to the west line of Campbell Street;
- (GGG) On the West side of Jean Court north of the north line of Caraway Street to the south edge of the Jean Court cul-de-sac;
- (HHH) On the West side of Campbell Street north of the north line of Minerva Street to the southwest line of Lafayette Avenue;
- (III) On the East side of Campbell Street north of the north line of Caraway Street to the southwest line of Lafayette Avenue;
- (JJJ) On the West side of Evelyn Way north of the north line of Caraway Street to the south line of Bibler Street;

- (KKK) On the Easterly side of Bibler Street north of the north line of Caraway Street to the east line of Evelyn Way;
- (LLL) On the North side of Yates Street northwest of the northwest line of Campbell Street to the east line of Evelyn Way;
- (MMM) On the West side of Cohen Street north of the north line of Caraway Street to the southwest line of Bibler Street;
- (NNN) On the South side of Geneva Court west of the west line of Cohen Street to the east edge of the Geneva Court cul-de-sac;

Section 3. The remaining portions of Chapter 77 in the City Code of Ordinances are not affected by this Ordinance and shall remain in full force and effect.

Section 4. All prior ordinances or parts thereof inconsistent with any provision of this Ordinance are hereby repealed, to the extent of such inconsistency only, as of the effective date of this Ordinance, such repeal to have prospective effect only

Section 5. If any portion on this Ordinance is for any reason declared to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance so long as enforcement of the same can be given the same effect.

Section 6. This Ordinance shall be in full force and effect in accordance with Indiana Law, upon passage of any applicable waiting periods, all as provided by the laws of the State of Indiana.
