ORDINANCES & RESOLUTIONS

ORDINANCE 2020-06 AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON, BOONE COUNTY, INDIANA AMENDING ORDINANCE NO. 07-16, THE UNIFIED DEVELOPMENT ORDINANCE OF THE CITY OF LEBANON, INDIANA. LEBANON YOUTH COUNCIL – REQUEST FOR GRANT FUNDS FOR MURAL –
Lebanon Youth Council representatives discuss a Mural, to be painted in the alley on Main St. across from the Courthouse and will depict Past, Present and Future for Lebanon High School Graduates. Scott Trafford, local mural artist will paint the mural, Scott stated he will paint a UV protective coating over the mural. The total cost of the mural is estimated to cost \$5,000. The LYC applied for a Grant from the State QUIP Impact Placemaking Grant and they received \$2500 from the State and now would like to request an additional \$2500 from the Council. Discussion follows.

Motion by Councilmember Robertson to approve the request for \$2500 to be paid from Casino/Riverboat Fund, subject to Historic Preservation Commission approval, 2nd by Councilmember Copeland. Motion carries by a unanimous vote.
