ORDINANCE 2020-10 – AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE CITY OF LEBANON, INDIANA BEGINNING JANUARY 1, 2021.

ORDINANCE 2020-12 – AN ORDINANCE FIXING THE SALARIES OF ELECTED OFFICIALS OF THE CITY OF LEBANON BEGINNING JANUARY 1, 2021. Clerk-Treasurer Tonya Thayer reads the Ordinance on second reading.

Motion by Councilmember Jones to approve Ordinance 2020-12, 2nd by Councilmember Messenger. Motion carries by a unanimous vote.

RESOLUTION 2020-08 – A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA APPROVING AN AMENDING DECLARATORY RESOLUTION AND PLAN SUPPLEMENT OF THE LEBANON REDEVELOPMENT COMMISSION AND ORDER OF THE LEBANON PLAN COMMISSION – Attorney Rob Schein reads Resolution.

ORDINANCE 2020-13 – AN ORDINANCE OF THE CITY OF LEBANON, INDIANA AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS FOR THE PURPOSE OF PROVIDING FUNDS TO PAY THE COSTS OF CERTAIN CAPITAL IMPROVEMENTS WITHIN THE CITY AND RELATED EXPENSES IN CONNECTION THEREWITH AND ON ACCOUNT OF THE ISSUANCE AND SALE OF THE BONDS AND APPROPRIATING THE PROCEEDS DERIVED FROM THE SALE OF SUCH BONDS. Attorney Rob Schein reads Ordinance on first reading.
