

Ordinance No. 00- 9

AN ORDINANCE AMENDING THE
LEBANON CITY CODE

WHEREAS, the Common Council of the City of Lebanon, Indiana, has reviewed the administrative sections of the Lebanon City Code and other miscellaneous sections and has determined that the Code should be up-dated and should accurately reflect common practices and accepted procedures; and

WHEREAS, the Council has determined that said Code should be recodified after correction and the City Attorney is hereby authorized to recodify said sections affected by these changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, as follows:

1. Section 2-13(3)(b) shall be changed to reflect that an ordinance is read two (2) times before passage;

2. Section 2-13(3)(c) shall be changed to reflect that resolutions may pass on one (1) reading;

3. Section 2-13(d) shall be changed to reflect that the Mayor Pro Tem is not president of the council and the ordinance should reflect that the Mayor Pro Tem acts in the Mayor's absence;

4. Section 2-5(d) shall be changed to reflect that the paragraph concerning Memory Hall shall be stricken;

5. Section 2-36(d) shall be changed to reflect that the name "Boone County State Bank" shall be replaced with the term "financial institution;"

6. The City Attorney shall amend Section 2-16 for calling special meetings of the Common Council by the deleting obsolete language and retaining the notice provisions required by law;

7. Section 2-42(a) shall be amended to show that the bond of the Clerk/Treasurer is determined by law;

8. Section 2-89 shall be amended to reflect that the fees for issuance of gun permits are collected by the Chief of Police or his/her designee;

9. Section 21-1 shall be deleted as it refers to a non-

existing police firing range;


10. Section 21-1 shall be reserved for future legislation;

11. Section 25-2 shall be deleted to remove language stating that the Lebanon Utilities is responsible for the Lebanon City Pool;


12. The City Attorney is authorized to recodify the sections as stated herein and to present the same to the Council for reading and to thereafter publish the same in accordance with law.


13. The amended provisions of the Lebanon City Code shall take effect on and after passage and publication as required by law.




