

Ordinance No. 00- 10

AN ORDINANCE AMENDING THE TRAFFIC CODE
TO SET SPEED LIMITS ON A PUBLIC STREET

WHEREAS, the Board of Public Works and Safety for the City of Lebanon has determined in accordance with a traffic survey conducted on Green Street and after a recommendation from the Committee reviewing the same, a lower than existing speed limit should be set on Green Street from South East Street to Hamilton Street; and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, pursuant to all applicable sections of the Indiana Code and the Lebanon City Code may regulate by ordinance traffic and motor vehicles within the City of Lebanon; and

WHEREAS, a necessity exists for the implementation of signage and notice to the general public along with the establishment of speed limits on Green Street, all for the public safety of the citizens of the City of Lebanon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

Section 1: Green Street shall be posted under a twenty mile per hour (20 mph) speed limit from South East Street east to Hamilton Street in the City of Lebanon, Indiana.

Section 2: Traffic signs shall be installed along said Green Street to inform the public and travelers thereon of the posted speed of 20 mph.

Section 3: The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of traffic regulations and the traffic speed pertaining to said public street.


Section 4: A violation of the provisions of the City Code and the traffic code pertaining to this traffic regulation, occurring after the adoption and effective date of this

ordinance, shall amount to a traffic violation and a fine shall be imposed as set by the Lebanon City Court for like offenses. Each time of the offense shall constitute a new and separate offense.


Section 5: The traffic code of the City of Lebanon shall be amended and supplemented to reflect the speed limit on Green Street and all other affected ordinances shall be likewise amended or supplemented to reflect this change.


Section 6: This ordinance shall be in full force and effect from and after its passage and any publication which may be required of the same by law.
