Ordinance No. 00-

AN ORDINANCE AMENDING THE TRAFFIC CODE OF THE CITY OF LEBANON, STATE OF INDIANA

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, have determined that a change in the traffic regulations is necessary at the intersection of Meridian Street and Main Street to provide for traffic signage designating that traffic in both directions is required to make a complete stop; and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, pursuant to all applicable sections of the Indiana Code and the Lebanon City Code, may regulate by ordinance the traffic of motor vehicles in this particular area of the City; and

WHEREAS, the necessity exists for the implementation of signage and traffic flow regulation on these particular streets and these intersections for the public safety in the City of Lebanon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

<u>Section 1</u>: Stop signs shall be installed at the intersection of Meridian Street and Main Street and the automated traffic signals shall be removed.

<u>Section 2</u>: The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of traffic regulations pertaining to this intersection so named, all as located in the City of Lebanon, State of Indiana.

Section 3: A stop sign shall be located so as to impose the requirement of a four-way stop on Meridian Street in a north and south direction, and on Main Street in an east and west direction. The traffic will be controlled by stop signs and/or any other signage deemed appropriate by the Board of Public Safety.

<u>Section 4</u>: A violation of the provisions of the City Code pertaining to this traffic regulation on the streets and

intersection designated herein, occurring after the adoption of this ordinance, shall amount to a City of Lebanon ordinance violation and upon a finding of violation of such ordinance, the violator shall be fined in a sum not to exceed Twenty-five Dollars (\$25.00). Each time of the offense shall constitute a new and separate offense.

<u>Section 5</u>: This ordinance shall be in full force and effect from and after its passage and any publication which may be required of the same by law.
