

Ordinance No. 00-12AN ORDINANCE AMENDING ARTICLE III
OF THE LEBANON CITY CODE

WHEREAS, a need exists to up-date the provisions for contractor licensing and registration within the Lebanon City Code and to establish certain fees for certain licenses; and

WHEREAS, the office of the Lebanon Building Inspector has made certain recommendations to amend Article III in accordance with the proposals attached hereto and made a part hereof.



1. Article III of the Lebanon City Code is hereby amended in accordance with the proposed changes attached hereto and made a part hereof;

2. The City Attorney is authorized to recodify Section 7-39 of the Lebanon City Code, et. seq. to reflect the incorporation of amended language as authorized herein;

3. The recodification shall take effect after its publication as required by law.

TWO(2) COPIES OF BUDGET FORMS 4-4 AND 4-3 FOR ALL FUNDS AND DEPARTMENTS ARE MADE A PART OF THE BUDGET REPORT AND SUBMITTED HEREBIN.
