

Ordinance No. 0014**AN ORDINANCE AMENDING CHAPTER 24 AND 27
OF THE LEBANON CITY CODE**

BE IT ORDAINED, by the Common Council of the City of Lebanon, Indiana, as follows:

- I. Chapter 24, Subdivision Regulation, and Chapter 27, Zoning, is hereby amended to reflect the changing goals and standards of the City of Lebanon as expressed in the Lebanon Comprehensive Plan dated May, 1999. These amendments include the following Articles:
1. Subdivision Regulations Articles I through VI, (§§24-1-24-17, §§24-18-24-43, §§24-18-24-26, §§24-44-24-60, §§24-61-24-79, §§24-80-24-101, and §§24-102-24-103)
 2. Zoning Regulations Articles I through VIII, (§§27-1-227-13, §§27-14-27-61, §§27-62-27-79, §§27-80-27-97, §§27-98-27-112, §§27-113-27-126, §§27-127-27-139 and §§27-140-27-141)
 3. And the applicable sections of the Master Plan Code, Article VI, (Ordinance No. 74-15, § 1(33-2), 9-9-74)
- II. That the Lebanon City Zone Map, a map entitled "Lebanon, Indiana Zone map", dated 1974, and any amendments thereto shall be amended and become a part of the Lebanon City Zone Map by reference.
- III. The Lebanon City Zone Map, upon adoption, shall be designated the Official Zone Map and shall be identified by the signature of the Mayor attested by the Clerk-Treasurer, and bearing the seal of the City under the following words: "This is to certify that this is the Official Zone Map referred to in Section 30.4 of Chapter 27 of the Municipal Code of Lebanon, Indiana", adopted July 24, 2000
- IV. THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, under the authority of Chapter 174, Act of 1947 and all Acts amendatory or supplementary thereto by the General Assembly of the State of Indiana that the Zoning Code and Subdivision Control Ordinances of Lebanon, Indiana, dated July 24, 2000 and all amendments thereto, shall read as follows:
