

Ordinance No. 00-19

AN ORDINANCE AMENDING THE TRAFFIC CODE OF THE CITY OF LEBANON, STATE OF INDIANA

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, have determined that a change in the traffic regulations is necessary to provide for a one-way street; and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, pursuant to all applicable sections of the Indiana Code and the Lebanon City Code, may regulate by ordinance the traffic of motor vehicles in this particular area of the City; and

WHEREAS, the necessity exists for the implementation of signage and traffic flow regulation on this particular street and the intersections thereof for the public safety in the City of Lebanon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

Section 1: Howard Street from North East Street to Park Street shall become a one-way street which shall run in an easterly direction.

Section 2: The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of traffic regulations pertaining to Howard Street, all as located in the City of Lebanon, State of Indiana.

Section 3: A stop sign shall be located so as to impose the requirement of a stop on Howard Street at the intersection of Park Street in an easterly direction.

Section 4: A violation of the provisions of the City Code pertaining to this traffic regulation on the streets and intersection designated herein, occurring after the adoption of this ordinance, shall amount to a City of Lebanon ordinance violation and upon a finding of violation of such ordinance, the violator shall be fined in a sum not to exceed Twenty-five Dollars (\$25.00). Each time of the offense shall constitute a

new and separate offense.

Section 5: This ordinance shall be in full force and effect from and after its passage and any publication which may be required of the same by law.
