

Ordinance No. 03- 07

AN ORDINANCE AMENDING THE TRAFFIC CODE
OF THE CITY OF LEBANON, STATE OF INDIANA

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, have determined that a change in the traffic regulations is necessary to provide for traffic safety on Garfield Street; and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, and the Common Council, pursuant to all applicable sections of the Indiana Code and the Lebanon City Code, may regulate by ordinance the traffic of motor vehicles throughout the City; and

WHEREAS, the necessity exists for the implementation of signage and traffic flow regulation on this particular street and the intersections thereof for the public safety in the City of Lebanon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

Section 1: A four way stop shall be created at the intersection of Douglas Lane and Northfield Drive and the intersection of Northfield Drive and Garfield Street in the City of Lebanon.

Section 2: The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of traffic regulations pertaining to the above named intersections, all as located in the City of Lebanon, State of Indiana.


Section 3: A stop sign shall be located so as to impose the necessity of a four way stop on the intersections of Douglas Lane and Northfield Drive and Northfield Drive and Garfield Street.

Section 4: A violation of the provisions of the City Code pertaining to this traffic regulation on the streets and



Further, the Lebanon Building Inspector and/or the Office of the Clerk/Treasurer are hereby authorized to change the official zoning maps consistent with this ordinance.


