

RESOLUTION # 02-10

WHEREAS, the Common Council of the City of Lebanon reduced the necessary expenditures from July 1, 2002 through December 31, 2002, from the General Fund and Sanitation Fund Appropriations as follows:

- General Fund \$677,000.
- Sanitation Fund \$ 20,000.

WHEREAS, the reason the expenditures were reduced was to save the funds needed to purchase a building to house the Lebanon Municipal and Utilities offices and make improvements at the Street Department out of said Funds in the Year 2003; and


WHEREAS, it is necessary to document by Resolution the reason for the reduced appropriations.


NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Lebanon that:

CONSIDERED AND PASSED by the Common Council of the City of Lebanon this 9 day of September 2002.




