

RESOLUTION NO. 2013-14

**A RESOLUTION AUTHORIZING THE TRANSFER OF GRANT FUNDS RECEIVED BY
THE CITY TO THE RESPECTIVE DEPARTMENT OVERTIME FUND
FOR THE CITY OF LEBANON, INDIANA**

WHEREAS, the City of Lebanon, Boone County, Indiana, (“City”) by and through its Common Council (“Council”), may establish certain funds and authorize expenditures from those funds, pursuant to Indiana law; and

WHEREAS, the Lebanon Police Department (“LPD”) and Lebanon Fire Department (“LFD”) participate in certain projects funded in whole, or in part, by State or Federal funds; and

WHEREAS, As a Participating Agency, LPD and LFD provide officers to work on the enforcement of these projects, among which are Seatbelt Enforcement, DUI Task Force, and Fatal Accident Crash Team (FACT), during which officers from LPD and LFD perform functions relating to the enforcement of these projects (hereinafter “Projects”); and

WHEREAS, the City periodically receives reimbursement from the State of Indiana or the United States Government for the hours worked by officers of LPD and LFD on the Projects; and

WHEREAS, The City, by and through the budgeted overtime fund lines for LPD and LFD pay the officers for their work on these Projects for law enforcement, investigation and other activities related to the Projects; and

WHEREAS, It is in the best interests of the citizens of Lebanon for funds received from the State or Federal government for the Projects to be transferred directly into the respective LPD and LFD Overtime fund lines for use and reimbursement for work performed by the officers assigned to the Projects.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Lebanon, Boone County, Indiana that:

1. The Lebanon Clerk-Treasurer shall initially deposit any funds received for reimbursement for officers of LPD and LFD working on the Seatbelt Enforcement Grant (#265), DUI Task Force (#266) and FACT (#264) into the respective grant line established for such purposes.
2. The Lebanon Clerk-Treasurer is hereby authorized to then transfer such funds into the Overtime line for the respective department for officers working on such Projects.
3. If any provision of this Resolution is deemed by a Court of competent jurisdiction to be invalid, the remaining provisions of this Resolution shall remain valid.

4. This Resolution shall become effective upon adoption.
