

RESOLUTION NO. 2014-08

RESOLUTION RECOGNIZING NATIONAL LINEMAN APPRECIATION DAY

WHEREAS, the City of Lebanon, Boone County, Indiana ("City), may, pursuant to Indiana Law [IC §36-1-3 *et seq.* (Home Rule)], enact Resolutions for effective governance;

WHEREAS, the Common Council of the City of Lebanon created the Lebanon Utility Service Board to facilitate the provisions of utility services in the City;

WHEREAS, Lebanon Utilities has an electrical service division for the purposes of distributing electrical energy to residential, commercial and industrial consumers within the municipality; and in doing so Lebanon Utility has in its employ Lineman; and

WHEREAS, the Senate of the United States adopted Senate Resolution 95 recognizing Lineman, the profession of Lineman, the contribution of these brave men and women who protect public safety, and expressing support for the designation of April 18th as National Lineman Appreciation Day;

WHEREAS, the profession of Lineman is steeped in personal, family and professional tradition;

WHEREAS, Lineman are often first responders during storms and other catastrophic events, working to make the scene safe for other public safety heroes;

WHEREAS, Lineman work with thousands of volts of electricity high atop power lines 24 hours a day, 365 days a year, to keep electricity flowing;

WHEREAS, Lineman must often work under dangerous conditions far from their families to construct and maintain the energy infrastructure of the United States;

WHEREAS, Lineman put their lives on the line every day with little recognition from the community regarding the danger of their work.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon recognizes the efforts of Lineman in keeping the power on and protecting public safety and supports the designation of April 18th as National Lineman Appreciation Day.
