

Ordinance No.15- 04  
Amending Ordinance §52.03

ORDINANCE ADJUSTING THE SALARY OF LEBANON UTILITY SERVICE BOARD MEMBERS

WHEREAS, the annual salary of Lebanon Utility Service Board Members ("Board Members") has not been changed in more than ten (10) years (*see* Code of Ordinances for the City of Lebanon); and

WHEREAS, the current salary paid to Board Members does not reflect the level of expertise required for the position, and does not adequately compensate Board Members for the amount of time required to fulfill the obligations of the position; and


WHEREAS, the salary of Board Members needs to be adjusted to account for changes in the cost of living, amount of time and collateral expenses connected to fulfilling the obligations of the position.

WHEREAS, the annual compensation of Board Members shall be adjusted to Five Thousand Dollars (\$5,000.00), paid equally at the end of each quarter annually. Each quarter payment shall be pro-rated as follows: Electric – 31%; Water – 31%; Wastewater – 31%; and Telecom – 7%; and

WHEREAS, §52.03 of the Code of Ordinances for the City of Lebanon must be amended to adjust the salary of Board Members.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon that §52.03 of the Code of Ordinances for the City of Lebanon is amended by replacing the words "\$2,400 per year" with "\$5,000 per year".

All of which is CONSIDERED, APPROVED AND ADOPTED by the Common Council of the City of Lebanon, Indiana this 23<sup>rd</sup> day of FEBRUARY, 2015.


