

ORDINANCE NO. 2015 - 06

**AN ORDINANCE REGULATING AND CONTROLLING VEHICULAR TRAFFIC AND
PARKING ON LEBANON COMMUNITY SCHOOL CORPORATION PROPERTY
WITHIN THE CITY OF LEBANON**

WHEREAS, the Acts of the General Assembly of the State of Indiana, as set forth at IND. CODE § 9-21-1-3(a)(13), empower and authorize a municipality, by and through its common council, to adopt an ordinance regulating traffic movement, parking and controls on public school grounds when requested by the governing body of the local school corporation; and

WHEREAS, the Board of Trustees ("School Board") is the governing body of the Lebanon Community School Corporation ("School Corporation"), which owns and maintains real property in the City on which is located various public school buildings and related facilities of the School Corporation; and

WHEREAS, the School Board has requested the Council enact a traffic control and parking ordinance for School Corporation property; and

WHEREAS, the School Corporation has established a Security/Police Department in accordance with IND. CODE § 20-26-16, and

WHEREAS, in order to promote and preserve the peace, health, safety, and general welfare of the municipality and its citizens, the Council is adopting this ordinance to take effect immediately after publishing notice of the same in the local newspaper, posting of such regulations in the Administrative Office of the School Corporation and erection of signs at one or more prominent locations on School Corporation property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF LEBANON:

Section 1: Definitions: This ordinance incorporates by references the definitions contained in Lebanon City Code § 70.02.

Section 2: Traffic Control: No motor vehicle, inotorcycle, or other motorized device for conveyance of persons and/or property shall be operated or parked on School Corporation property, except in compliance with the following restrictions:

- (a) No vehicle shall be operated at a speed in excess of twenty (20) miles per hour;
- (b) All vehicles parked on said property shall be parked only within areas marked and designated for vehicular parking.
- (c) Parking spaces or areas marked or posted as reserved for use by handicapped persons may be used only by vehicles displaying the a current and appropriate handicapped vehicle sticker;
- (d) Parking spaces or areas marked or posted as reserved for use by law enforcement, public safety or emergency vehicles may be used only by such vehicles authorized to use them;
- (e) The operators of all vehicles shall observe and comply with proper driving lanes and one-way traffic lanes as designated by traffic control signs or makings in place on said property;
- (f) The operators of all vehicles shall stop and yield the right-of-way in compliance with stop or yield signs or markings on said property; and
- (g) All vehicles shall be operated and maintained in accordance with the general rules of the road as established by Indiana law and with due care for the safety of other persons or property in the vicinity.

Section 3: Penalties: The operator of vehicles violating the above regulations shall be subject to a civil fine in the sum of twenty-five dollars (\$25) per violation in addition to any court costs imposed or required by law.

Section 4: Enforcement: Officers of the School Corporation Security/Police Department and authorized law enforcement officers of the City of Lebanon, Boone County Sheriff, or


Indiana State Police shall have the authority to enforce this ordinance by proceedings initiated in the Boone Superior Court II, Lebanon, Indiana.


Section 5: Proceeds: Fines collected for a violation of this ordinance shall be deposited into the general fund of the School Corporation.


Section 6: Severability: If any section, paragraph, clause, phrase or part of this ordinance is held invalid by any court of competent jurisdiction, or by any agency, department, or commission empowered by statute for such purpose, such decision shall not affect the validity of the remaining provisions of this ordinance and the application of those provisions to any person or circumstances shall not be affected thereby.


