

ORDINANCE 2015-09

COMMON COUNCIL FOR THE CITY OF LEBANON, INDIANA

AN ORDINANCE ADOPTING GENERAL TERMS AND CONDITIONS FOR WATER, WASTEWATER, AND ELECTRIC CUSTOMERS OF LEBANON UTILITIES (Affecting Ordinances §53.05; §53.07; §53.08; §53.09; §53.10; §54.05; §§54.20- 54.30; §54.45; §54.46; §54.47; & §55.076)

WHEREAS, the City of Lebanon, Indiana (the "City") owns and operates by and through the Lebanon Utility Service Board (the "Board"), a municipally owned utility known as Lebanon Utilities (the "Utility"); and

WHEREAS, the Utility has water, wastewater, and electric service divisions for the purposes of distributing utility services to residential, commercial, and industrial consumers within the City; and

WHEREAS, it is in the public interest to adopt and publish general terms and conditions for the Utility's provision of water, wastewater, and electric services to customers; and

WHEREAS, the Board has promulgated and approved General Terms and Conditions for Wastewater Service, Water Service, and Electric Service (the "General Terms and Conditions"), which are attached hereto as Exhibits "1", "2", & "3" respectively; and

WHEREAS, the General Terms and Conditions are intended to supplement and embody existing ordinances, rules, and regulations concerning the terms and conditions of the Utility's provision of water, wastewater, and electric services, including §53.05, §53.07, §53.08, §53.09, §53.10, §54.05, §§54.20 through 54.30, §54.45, §54.46, §54.47, and §55.076 of the Code of Ordinances for the City of Lebanon.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon that the General Terms and Conditions for Wastewater Service, Water Service, and Electric Service adopted by the Lebanon Utility Service Board are hereby adopted.






