

ORDINANCE NO. 2016-08

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON,
BOONE COUNTY, INDIANA CONCERNING AMENDMENT TO CHAPTER 77 –
PARKING SCHEDULES**

WHEREAS, pursuant to Indiana Code § 9-21-1-3(a)(1), the City of Lebanon, Indiana (“City”), within the reasonable exercise of its police power, may by ordinance regulate vehicular parking; and

WHEREAS, the City has previously regulated vehicular parking within its corporate limits, such regulations being codified, in part, in City Code of Ordinances, Chapter 77 – Schedule I;

WHEREAS, the Common Council of the City now finds that it is in the interests of public safety and welfare to further regulate parking on certain portions of Shorewood Drive.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon, Boone County, Indiana, meeting in regular session, as follows:

Section 1. The foregoing Recitals are incorporated herein by this reference.

Section 2. As of the effective date of this Ordinance, Chapter 77 – Schedule I of the City Code of Ordinances shall read as follows:

(U) On the east and west side of Shorewood Drive, from the subdivision entrance intersection with Anderson Lane to approximately 215 feet along Shorewood Drive.

Section 3. The remaining portions of Chapter 77 in the City Code of Ordinances are not affected by this Ordinance and shall remain in full force and effect.

Section 4. All prior ordinances or parts thereof inconsistent with any provision of this Ordinance are hereby repealed, to the extent of such inconsistency only, as of the effective date of this Ordinance, such repeal to have prospective effect only

Section 5. If any portion on this Ordinance is for any reason declared to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance so long as enforcement of the same can be given the same effect.

Section 6. This Ordinance shall be in full force and effect in accordance with Indiana Law, upon passage of any applicable waiting periods, all as provided by the laws of the State of Indiana.





CHAPTER 77: PARKING SCHEDULES

Schedule

- I. Parking prohibited
- II. Handicapped parking

SCHEDULE I. PARKING PROHIBITED.

Parking shall be prohibited as follows:

- (A) On the north side of Essex Street between the west curb line of North Lebanon Street and the east curb line of Garfield Street;
- (B) On the south side of East Busby Street from North East Street to Park Street;
- (C) On the west side of South Meridian Street from the north curb line of West Ash Street north to the first alley;
- (D) On the north side of Esplanade Street between North Lebanon Street and West Street and also on the south side of Esplanade Street for a distance of 75 feet west from the west curb line of North Lebanon Street;
- (E) On the south side of Fordice Street between East Street and Lebanon Street;
- (F) On the south side of East Washington Street between Park Street and Grant Street;
- (G) On the south side of West Main Street between the first alley west of West Street and the second alley west of West Street;
- (H) On the north side of Busby Street from Lebanon Street to Meridian Street;
- (I) In the midblock crosswalks on the north, east and south sides of the courthouse square;
- (J) On the south side of West Dicks Street, from South Lebanon Street to Patterson Street;
- (K) On the south side of Green Street, except for an unloading zone on the south side of the street next to the church on the corner of South Lebanon Street and West Green Street;
- (L) On the east side of Coombs Street from the Indiana Central right-of-way south to Noble Street;
- (M) On the south of West Ash Street, from South Lebanon Street to Coombs Street;
- (N) On the south side of West Walnut Street, from South Lebanon Street to Coombs Street;

- (O) On the west side of North Kersey Street, between Chicago Street and Franklin Street;
 - (P) On the north side of Busby Street between North Meridian Street and North Lebanon Street (SR 39);
 - (Q) On the south side of Busby Street from North Lebanon Street (SR 39) to North West Street;
 - (R) On the south side of Chicago Street from North Meridian Street to North Lebanon Street (SR 39);
 - (S) No motor vehicle shall be parked in excess of ten minutes between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday and 8:00 a.m. and 11:00 a.m. on Saturday on the north side of West Main Street between North West Street and the alley on the west side of the United States post office having an address of 304 West Main Street; and
 - (T) On the south side of Somerset Drive west of Grant Street between April 1 and October 1.

SCHEDULE II. HANDICAPPED PARKING.

(A) Handicapped parking.

- (1) There is established a handicapped parking space on the west side of North Lebanon Street directly north of the alley running east and west which bisects the County Courthouse, which space is presently and shall continue to be a parallel parking space.
- (2) There is established a handicapped parking space on the north side of Washington Street at the intersection of Washington and West Streets, adjacent to the County License Branch and two handicapped parking spaces adjacent to the southwest door to the gymnasium of Memory Hall.

(B) Penalty.

- (1) A violation of division (A)(1) shall amount to a city ordinance violation and upon a finding of violation, the violator shall be fined in a sum not to exceed \$25. Each day of the violation shall constitute a new and separate offense.
- (2) A violation of division (A)(2) shall amount to a city ordinance violation and upon a finding of violation, the violator shall be fined in a sum not to exceed \$25. Each day of the violation shall constitute a new and separate offense.
