

ORDINANCE NO. 2016-14

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON,
BOONE COUNTY, INDIANA CONCERNING AMENDMENT TO CHAPTER 76 –
TRAFFIC SCHEDULES**

THREE-WAY STOP AT EAST WILLIAMS STREET AND NORTH PARK STREET

WHEREAS, Indiana statute provides for a municipality to regulate motor vehicle traffic within its corporate boundaries;

WHEREAS, the Common Council of the City of Lebanon, Indiana (“City”) has jurisdiction over the public thoroughfares and streets within the corporate boundaries of the City;

WHEREAS, the intersection of East Williams Street and North Park Street (the “Intersection”) does not adequately regulate vehicular traffic flow;

WHEREAS, the Common Council of the City believes it is in the best interests of the public’s health, safety, and welfare to install permanent signage necessary to make the Intersection a three-way stop, wherein vehicles approaching the intersection from each direction will be required to stop;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon, Boone County, Indiana, meeting in regular session, as follows:

- Section 1.** The foregoing Recitals are incorporated herein by this reference.
- Section 2.** As of the effective date of this Ordinance, Chapter 76 – Schedule V. Stop Intersections of the City Code of Ordinances shall be amended and establish the Intersection as a three-way stop.
- Section 3.** The remaining portions of Chapter 76 of the City Code of Ordinances are not affected by this Ordinance and shall remain in full force and effect.
- Section 4.** All prior ordinances or parts thereof inconsistent with any provision of this Ordinance are hereby rescinded, to the extent of such inconsistency only, as of the effective date of this Ordinance, such repeal to have prospective effect only.


