

**RESOLUTION 2017-03**

**A RESOLUTION OF THE COMMON COUNCIL OF THE  
CITY OF LEBANON, INDIANA, TO NAME PROPERTY AS REESE PARK AFTER  
FORMER MAYOR EARL R. REESE (1949-1951)**

**WHEREAS**, the City of Lebanon, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to maintain the integrity of all property owned by the City; and

**WHEREAS**, the City wishes to name the property located on Maple Drive between SR 39 and Garfield Street, as Reese Park, after former City Mayor Earl R. Reese;

**WHEREAS**, the City acknowledges and appreciates Mayor Reese’s significant accomplishments to the City to support the naming of Reese Park, including but not limited to the following:

1. Establishing a Community Service Council, as a goal to provide recreation for the citizens of Lebanon;
2. Leasing nine acres to the Lebanon School system for the purpose of constructing a football field and cinder track;
3. Relocating the City offices to the Courthouse; and
4. Hosting a three hour dedication ceremony of the U.S. 52 by-pass, which included Governor Henry Schricker, State Highway Commissioner Samuel Hadden, and world-famous contractor Henry Ulen.

**NOW, THEREFORE**, be it resolved and adopted by the Common Council of the City of Lebanon, Indiana as follows:

**Section 1.** That the Council and Mayor of the City do hereby approve the naming of Reese Park.

**Section 2.** This Resolution shall be in full force and effect upon adoption and all acts undertaken to create this Resolution are hereby ratified.




