

RESOLUTION 2017-06

**A RESOLUTION OF THE COMMON COUNCIL OF THE
CITY OF LEBANON, INDIANA, ADOPTING A TITLE VI OF THE CIVIL RIGHTS
ACT OF 1964 PLAN**

WHEREAS, the federal government enacted Title VI of the Civil Rights Act of 1964, as amended, to prevent discrimination on the grounds of race, color, sex, age, disability or national origin and to ensure that individuals are not excluded from participation in, denied benefits of, or otherwise subjected to discrimination under any program or activity receiving federal financial assistance on the basis of race, color, sex, age, disability or national origin;

WHEREAS, throughout the years, additional regulations, statutes, directives, cases and executive orders have been passed which expand the breadth of Title VI; and

WHEREAS, in compliance with the Title VI of the Civil Rights Act of 1964, the City of Lebanon shall adopt and implement a Title VI Non-Discrimination Plan to provide equal opportunity and equitable services for the citizens of Lebanon, Indiana;

WHEREAS, it is a requirement of the Indiana Department of Transportation and the US Department of Transportation that communities receiving federal financial assistance adopt a Title VI Non-Discrimination Plan;

NOW, THEREFORE, be it resolved by the Common Council of the City of Lebanon, Indiana as follows:

Section 1. The Title VI Non-Discrimination Plan, attached hereto and incorporated herein as **Exhibit A**, is adopted.

Section 2. This Resolution shall be in full force and effect immediately upon its adoption.




