

**RESOLUTION 2017-12**

**A RESOLUTION OF THE COMMON COUNCIL OF THE  
CITY OF LEBANON, INDIANA, FOR ADDITIONAL APPROPRIATION**

**WHEREAS**, the City of Lebanon (the "City") is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (the "Council");

**WHEREAS**, it is the duty and the responsibility of the Council to maintain fiscal integrity of the finances of the City;

**WHEREAS**, at times it becomes necessary to appropriate additional funds within the approved budget as contemplated and authorized under IC § 36-4-7-9 and IC § 6-1.1-18;

**WHEREAS**, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget;

**WHEREAS**, all additional appropriations require a public hearing, of which the Council has served proper notice in accordance with IC § 5-3-1; and

**NOW, THEREFORE**, be it resolved and adopted by the Council of the City as follows:

**Section 1.** Resolution 2017-12 is to appropriate funds for the Community Crossing Grant street projects & ADA sidewalk ramps.

**Section 2.** The following additional sums of money are hereby appropriated out of **FUND 260 – Local Road & Bridge Matching Grant Fund** and for the purpose specified, subject to laws governing the same:
