**A RESOLUTION OF THE COMMON COUNCIL OF THE
CITY OF LEBANON, INDIANA, FOR BUDGET RE- APPROPRIATION**

WHEREAS, the City of Lebanon (the “City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (the “Council”);

WHEREAS, it is the duty and the responsibility of the Council to maintain fiscal integrity of the finances of the City;

WHEREAS, at times it becomes necessary to re-appropriate funds within the approved budget as contemplated and authorized under IC § 36-4-7-9 and IC § 6-1.1-18;

WHEREAS, it has been determined that it is now necessary to re-appropriate money within the originally appropriated annual budget;

WHEREAS, all re-appropriations require a public hearing, of which the Council has served proper notice in accordance with IC § 5-3-1; and

NOW, THEREFORE, be it resolved and adopted by the Council of the City as follows:

Section 1. Resolution 2017- 23 is to re-appropriate funds within the dept. of Active Living in order to finish the 2017 Trail work.

Section 2. The following sums of money are hereby re-appropriated within **FUND 101 Dept. 032 – Active Living** and for the purpose specified, subject to




