

RESOLUTION 2018-01

**A RESOLUTION OF THE COMMON COUNCIL OF THE
CITY OF LEBANON, INDIANA, FOR ADDITIONAL APPROPRIATION**

WHEREAS, the City of Lebanon (the “City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (the “Council”);

WHEREAS, it is the duty and the responsibility of the Council to maintain fiscal integrity of the finances of the City;

WHEREAS, at times it becomes necessary to appropriate additional funds within the approved budget as contemplated and authorized under IC § 36-4-7-9 and IC § 6-1.1-18;

WHEREAS, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget;

WHEREAS, all additional appropriations require a public hearing, of which the Council has served proper notice in accordance with IC § 5-3-1; and

NOW, THEREFORE, be it resolved and adopted by the Council of the City as follows:

Section 1. Resolution 2018- 01 is to appropriate funds for the East St. sidewalk project.

Section 2. The following additional sums of money are hereby appropriated out of **FUND 950 – Special LOIT Distribution 25%** and for the purpose specified, subject to laws governing the same:
