

**ORDINANCE 2018-17**

**AN ORDINANCE FIXING THE SALARIES OF ELECTED OFFICIALS  
OF THE CITY OF LEBANON BEGINNING JANUARY 1, 2019**

SECTION 1: BE IT ORDAINED BY THE COMMON COUNCIL of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein:

SECTION 2: That the maximum salaries of the following elected officials of the City of Lebanon, beginning January 1, 2019, are as follows:

MAYOR	\$51,766
CLERK-TREASURER	\$55,298
COMMON COUNCIL ( <u>7@</u> \$5,407.50/yr)	\$37,853

SECTION 3: In addition to funds paid by the Civil City as set out in Section 2 above, the following elected and appointed officers to be paid from funds of the Municipal Utilities are as follows:

MAYOR	\$26,866
CLERK-TREASURER	\$15,360
DEPUTY CLERK-TREASURER	\$26,995

SECTION 4: This Ordinance shall take effect January 1, 2019
