**ORDINANCE NO. 2021-06**

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON,  
BOONE COUNTY, INDIANA CONCERNING AMENDMENT TO CHAPTER 76 –  
TRAFFIC SCHEDULES**

**WHEREAS**, the City of Lebanon (the “City”) is a duly formed municipal corporation within the State of Indiana governed by its duly elected Mayor and Common Council (“Common Council”);

**WHEREAS** Indiana Code provides for a municipality to regulate motor vehicle traffic within its corporate boundaries;

**WHEREAS**, the Common Council of the City of Lebanon, Indiana (“City”) has jurisdiction over the public thoroughfares and streets within the corporate boundaries of the City;

**WHEREAS**, the Common Council of the City believes it is in the best interests of the public’s health, safety and welfare to amend Chapter 76 – Traffic Schedules.

**NOW, THEREFORE, BE IT ORDAINED** by the Common Council of the City of Lebanon, Boone County, Indiana, meeting in regular session, as follows:

**Section 1.** The foregoing Recitals are incorporated herein by this reference.

**Section 2.** As of the effective date of this Ordinance, Chapter 76 – Schedule V. Stop Intersections of the City Code of Ordinances shall be amended to include the following:

A. Witt Road and Robinson Run: 4-way stop;

**Section 3.** The remaining portions of Chapter 76 of the City Code of Ordinances are not affected by this Ordinance and shall remain in full force and effect.

**Section 4.** This Ordinance shall be in full force and effect in accordance with Indiana Law, upon passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof in conflict herewith are hereby ordered amended or repealed. All acts pursuant to the adoption of this ordinance are hereby ratified.


