**A RESOLUTION OF THE COMMON COUNCIL OF THE
CITY OF LEBANON, INDIANA ADOPTING THE AMERICANS WITH DISABILITIES
ACT SELF-EVALUATION AND TRANSITION PLAN - UPDATE**

WHEREAS, the Federal government enacted the Americans with Disabilities Act of 1990 (ADA) to prevent discrimination of the physically and mentally disabled relating to employment and access to public facilities; and,

WHEREAS, Title II of the ADA requires all public entities with 50 or more employees perform a self-evaluation, prepare a transition plan, make the transition plan available, publish a notice of non-discrimination, designate an ADA Coordinator, and develop a formal complaint form and grievance procedure; and,

WHEREAS, the City of Lebanon (City) contracted with a consultant in 2012 to perform a self-evaluation of City facilities, including facilities within the public right-of-way (ROW), and prepare a Transition Plan; and,

WHEREAS, in late 2018, the City contracted with DLZ Indiana, LLC to perform and update of the 2012 Transition Plan.

WHEREAS, the United States Department of Justice modified the ADA Standards for Accessible Design and the Guidelines for Pedestrian Facilities in the ROW in 2010 and 2011, respectively; and,

WHEREAS, the City of Lebanon remains committed to the ADA and the elimination of barriers to public facilities.

NOW, THEREFORE, be it resolved that the Common Council of the City of Lebanon adopts the Americans with Disabilities Act Self-Evaluation and Transition Plan – Update, attached hereto as Exhibit A.
