ORDINANCE NO. 31 - AN ORDINANCE TO REGULATE PARKING ON CERTAIN STREETS IN THE CITY OF LEBANON, INDIANA AND PROVIDING PENALTY FOR THE VIOLATION THEREOF, AND REPEALING ORDINANCE NO. 28, 1956, PASSED BY THE COMMON COUNCIL ON THE 10th DAY OF SEPTEMBER, 1956.

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein that:

SECTION 1. That there shall be no parking on the side of the following described North and South Streets in said City as set out below:

- West side of Grant Street from Fordice to Indianapolis Avenue.
- 2. West side of Park Street from Fordice to North Street.
- West side of East Street from Fordice to North Street.
- West side of East Street from Elm to Thompson Street. 5. West side of Meridian Street from North to Ulen Drive.
- 6. East side of Clark Street from Williams to Chicago Street.
- 7. West side of West Street from Williams to North Street.
- 8. East side of Ryan Street from Main to Elm Street.

9. West side of Lafayette Avenue from Underpass to Main Street.

SECTION 2. That there shall be no parking on the side of the following described streets in said City which are set out below:

- 1. South side of Royal Street from Meridian to Lafayette Avenue. North side of Main Street from Lafayette Avenue to C Street.
- South side of Dicks Street from Lebanon Street to Pleasant acres addition.
- South side of Walnut Street from Lebanon Street to Sunset addition.
- 5. South side of Noble Street from Indianapolis Avenue to C Street.

6. South side of Fordice Street from Meridian to East Street.

SECTION 3. That there shall be No Parking on pavement on the following streets in said City.

- 1. East Street from Thompson Street to Bypass.
- 2. Ulen Drive from City Limits to North Lebanon Street.
- 3. Lafayette Avenue from City Limits to Underpass. 4. Camp Street from Ulen Drive to Lafayette Avenue.
- 5. Fordice Street from City Limits to East Street.
- Main Street from C Street west to South Street.
- Noble Street from Road 32 to Indianapolis Avenue.
- Park Street from North Street to Main Street.
- 9. C Street from Lafayette Avenue to Bypass.

SECTION 4. Any person or persons failing or refusing to comply with said order shall be guilty of a misdemeanor and upon conviction, shall be fined not less than one (\$1.00) dollar and not more than twenty five (\$25.00) dollars plus cost of prosecution.

SECTION 5. An ordinance passed by the Common Council on the 10th day of September, 1956, entitled, Ordinance No. 28, An Ordinance To Regulate Parking On Certain Streets In The City of Lebanon, Indiana and Providing Penalty For The Violation Thereof, is hereby repealed.

SECTION 6. This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor and publication according to law.
