ORDINANCE NO. 35 - AN ORDINANCE TO REGULATE THE PRODUCTION, TRANSPORTATION, PROCESSING, HANDLING, SAMPLING, EXAMINATION, LABELING, AND SALE OF MILK AND MILK PRODUCTS; THE INSPECTION OF DAIRY HERDS, DAIRIES, AND MILK PLANTS; THE ISSUING AND REVOCATION OF PERMITS TO MILK PRODUCERS, MILK HAULERS, AND DISTRIBUTORS; PERMIT FEES; APPOINTMENT OF INSPECTORS AND SANITARY POLICE; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND FIXING PENALTIES.

Be it ordained by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein, that:

SECTION 1. The health officer having jurisdiction within the territorial limits of the City of Lebanon, Indiana, or his authorized representative shall have supervision over the production, transportation, processing, handling, sampling, examination, grading and regrading, labeling, and sale of all milk and milk products sold at retail or wholesale within the City of Lebanon, Indiana or its police jurisdiction; the inspection of dairy herds, dairies, and milk plants; and the issuing and revocation of permits to milk producers, milk haulers, and distributors.
