RESOLUTION OF COMMON COUNCIL AUTHORIZING
AND ORDERING PROCEEDINGS TO RAISE WATER RATES.

Whereas, Lebanon Utility Service Board has presented a resolution to the Common Council, by which it recommends and requests the Council for proper authorization and order for proceedings to be instituted to adjust and raise the rates of Lebanon Water Works, and

Whereas, after due consideration of said request and being advised in the premises it is now found and determined that the present water rates are insufficient to properly maintain the physical structure of the plant and to provide it with working capital, and to provide funds needed for expansion, and it is further found and determined that to provide such funds, a new rate should be established as follows:
