

point being the southwest corner of Allied Builders, Inc., subdivision of Out lot No. 1 of United Builders, Inc., Northfield Village, Lebanon, Ind. being also in the north line of Allied Builders, Inc. Northfield Village Second Section, run thence west along and with the north line of Allied Builders, Inc. Northfield Village Second and Third Section 413.64 feet to the northwest corner of Allied Builders, Inc. Northfield Village Third Section, said point being also the northeast corner of Allied Builders, Inc. Northfield Village Fourth Section: thence continue west along and with the north line of Allied Builders, Inc., Fourth Section and said north line projected westwardly 794.89 feet to a point in the east right-of-way line of the Pennsylvania Railroad: thence north deflecting right 89°44' along and with the aforesaid east right-of-way line 147.95 feet to a point; thence continue northwardly along and with the aforesaid east right-of-way line and on a curve to the left a distance of 150.00 feet to a point; thence eastwardly 1209.80 feet to a point in the west line of Allied Builders, Inc., Subdivision of Outlot No. 1 of United Builders, Inc. Northfield Village, said thereof; thence south along and with the aforesaid west line of said Out-lot No. 1 a distance of 297.95 feet to the place of beginning containing 8.30 acres, more or less which real estate is owned in fee simple by Allied Builders, Inc. who have petitioned this Council for the annexation and approval of the plat thereof, which plat has been dedicated and acknowledged by said fee simple owners to the City of Lebanon, Indiana; which dedication and acknowledgment is subject to certain protective covenants and restrictions all as set out in said dedication and acknowledgment; and which dedication and acknowledgment contain certain rights of way for public uses and easements for public utilities all as set out in said dedication and acknowledgment; and which described real estate is shown by a survey and affidavit of P.W. Moore, registered engineer #2373 of the State of Indiana, to be adjoining to and contiguous to the present boundary lines of said City; that said real estate as is hereinbefore described be and is declared by action of the Common Council of the City of Lebanon, Indiana, to be annexed to and a part of said City of Lebanon, Indiana.

SECTION 2: This ordinance shall take effect from and after its passage by the Common Council, approval by the Mayor, and publication according to law.
