

AGREEMENT

Filed - Sanitary Landfill contracts

This Agreement made and entered into by and between The City of Lebanon, Indiana acting by its Board of Public Works and Safety and William Minkner, upon the following terms and conditions WITNESSETH:

The parties hereto agree:

1. The City of Lebanon, Indiana will permit William Minkner to haul, and dump, trash refuse and garbage upon the site of the sanitary landfill operated by the City upon the farm owned by it.

2. As consideration for said permission William Minkner will pay into the office of the Clerk-Treasurer of the City of Lebanon, Indiana the sum of \$2.00 for each and every load which he hauls to said site and will dump only where directed by the person having charge of said site.

3. This agreement shall continue in effect until terminated upon 30 days notice given by either party.

4. This agreement shall be submitted to the Common Council for their approval and, after said approval, will be effective from and after May 22, 1957.
