SECTION 3: The annual salaries of the members of the Utility Service Board shall be \$500.00 each.

SECTION 4:

- A. The annual salary for Parking Meter Accounting to be paid from Parking Meter Funds to City Clerk-Treasurer, shall be \$1600.00.
- B. The annual salary of the Parking Meter Attendant, to be paid from Parking Meter Funds, shall be \$3840.00

SECTION 5:

- A. The annual salary of the Clerical Assistant to the Clerk-Treasurer shall be \$2200.00.

SECTION 6: Recreation Dept:

- A. Salary of Janitor----- \$ 19.00 weekly
