RESOLUTION DIRECTING THE CIVIL CITY TO ENTER INTO AN
AGREEMENT WITH THE UTILITY SERVICE BOARD AND AUTHORIZING
THE MAYOR TO SIGN SAID AGREEMENT.

WHEREAS, the City of Lebanon, Indiana is the owner of the following described real estate, to-wit:

Part of the southeast quarter of section 9, township 19 north range 1 west, described as follows, Commencing at the northwest corner of said tract running thence south along the west line thereof 943 feet, to the east line of the right of way of State Road No. 52, thence south 41 degrees 22 minutes east along the east line of the right of way of said road 2249 feet thence east 1165 feet parallel to the south line of said tract to a point 20 feet north of the southeast corner of said quarter section, thence north along the east line thereof 2483 feet or to a point 145 feet south of the northeast corner of said quarter section, thence west 541 feet, thence north 145 to the north line of said quarter section, thence west to the north line of said quarter section 2108 feet to the place of beginning containing 129.11 acres, more or less, subject to all legal high ways and rights of way.

and,

WHEREAS, said real estate was purchased by the Lebanon Utility Service Board out of the funds of the Lebanon Electric Utility, for the use of said Electric Utility, and

WHEREAS, the Civil City desired to use said land for a sanitary land fill operation, gravel removal, and general operation thereof, reserving to the Lebanon Electric Utility the necessary uses which they might require from said real estate,

NOW THEREFORE, BE IT RESOLVED, by the Common Council of the City of Lebanon, Indiana:

SECTION 1. That the Civil City of Lebanon, Indiana enter into an agreement with the Lebanon Utility Service Board for the use of the above described real estate for the above set out purposes.

SECTION 2. That the Mayor of the City of Lebanon, Indiana is hereby authorized and directed to execute and sign said agreement.
