ORDINANCE NO. 57 - AN EMERGENCY APPROPRIATION ORDINANCE PROVIDING FOR ADDITIONAL APPROPRIATION FOR THE DEPARTMENTS NAMED FOR THE YEAR 1958, AS RECOMMENDED BY THE CLERK-TREASURER OF THE CITY OF LEBANON, INDIANA.

WHEREAS; Certain extraordinary conditions have developed since the adoption of the existing annual budget, so that it is now necessary to appropriate more money than was appropriated in the annual budget for the variols functions of City Government, to meet such extraordinary emergencies:

SECTION 1. Be It Ordained By The Common Council of the City of Lebanon, Indiana, that for the expense of City Government the following sums of money are hereby appropriated and set apart out of the General Fund for the purposes herein specified, subject to the laws governing the same, such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law.

SECTION. 2. That for said fiscal period there is hereby appropriated out of the General Fund, the following specified amounts to meet such extraordinary emergencies which are hereby declared to exist:

GENERAL FUND:

GARBAGE DEPARTMENT

5B Supplies and Repairs - - - - - \$ 1000.00
5E Equipment Rental - - - - - 600.00

HEALTH DEPARTMENT

6C Expenses of Health Officer - - - - - 100.00

LAW DEPARTMENT

10C Court Expense, Change of Venue and Expert Witness Fee - - - - - 500.00

BE IT ORDAINED, by the Common Council of the City of Lebanon. Indiana, two-thirds of its members being present and concurring therein that:

SECTION 1. An ordinance entitled, "Ordinance Prohibiting Parking of Motor Vehicles or other Vehicles on Either Side of North Street Between C Street and Lafayette Ave." passed by the Common Council on April 9, 1945 as Ordinance No. 17, is hereby repealed.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor and publication according to law. Passed by the Common Council and approved by me this 12th day of May, 1958.
