

AGREEMENT*Filed agreement*

THIS AGREEMENT made and entered into this 27th day of April, 1959 by and between the City of Lebanon, Indiana hereinafter called the City and the Town of Sheridan, Indiana, hereinafter call the Town, upon the following terms and conditions, WITNESSETH:

1. The City hereby agrees to permit the Town to have access to and use the Sanitary Landfill owned and now being operated by the City on road No. 52, four miles north of Lebanon, Indiana, the use by the Town to be for the purpose of disposing of the garbage collected by the Town from its residents.

2. As consideration for the above and foregoing agreement on the part of the City, the Town hereby agrees to pay the sum of \$50.00 per month to the City; provided however, that should the Town have more than 15 barrels of garbage in any one week, they shall pay to the City an additional sum of 80¢ per barrel for each barrel over said 15 barrels, and an accurate count shall be kept of said barrels by the operator of said land fill. The Town further agrees to instruct its employees to dispost of its garbage at the direction of said operator.

3. It is further agreed that this agreement shall be for a term of One (1) year and shall continue in effect from year to year unless one party notifies the other of its intention to cancel the same given at least sixty (60) days prior to the end of the term hereof.

In Witness whereof, the parties hereto have set their respective hands and seals this 27th day of April, 1959, the City by its Board of Works and the Town by its Town Board.
