

SECTION 1. Be It Ordained By The Common Council of the City of Lebanon, Indiana, that for the expense of City Government the following sums of money are hereby appropriated and set apart out of the General Fund and Firemen's Pension Fund for the purposes herein specified, subject to the laws governing the same, such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law.

SECTION 2. That for said fiscal period there is hereby appropriated out of the General Fund, the following specified amounts to meet such extraordinary emergencies which are hereby declared to exist:

AGREEMENT *Filed - Agreements*

This agreement made and entered into by and between the City of Lebanon, Indiana, by its Board of Public Works and Safety, and the P. E. Middleton Co., Inc., Engineers, of Indianapolis, Indiana. The said City of Lebanon has employed the said P. E. Middleton Co., Inc., to render professional engineering services as outlined in this agreement, the services proposed in this contract which shall be performed by the said P. E. Middleton Co., Inc., shall consist of:

1. A survey to establish the corporation line of the City of Lebanon showing all distances and angles and establishing all corners on said line. The survey shall be prepared in accordance and with a degree of accuracy for normal second order surveys and the survey shall be closed with an error of not more than one in five thousand. The survey shall establish temporary markers at all corners of the aforesaid corporation line and the P. E. Middleton Co., Inc., will furnish supervision to establish permanent markers at all corners or reference said corners in the aforesaid corporation line. The City of Lebanon shall furnish the materials and labor necessary to set the permanent markers. A drawing shall be furnished the City of Lebanon showing the dimensions, angles and location of markers on the corporation line.

2. The P. E. Middleton Co., Inc., shall prepare a new map of the City of Lebanon showing the new corporation line and all recently platted and recorded subdivisions together with the original town and shall show streets, alleys, etc., as shown on the existing map but shall be brought to date and corrected insofar as it is possible to do so from the existing surveys, plats, maps, aerial photographs, etc. No actual field survey shall be made to prepare this map unless deemed necessary by P. E. Middleton Co., Inc., and such field work to be included in the quoted estimate for the map. The map shall be prepared on tracing cloth to a scale of one inch equals two hundred feet.

The City of Lebanon in consideration of the services of the P. E. Middleton Co., Inc., agrees to pay the said P. E. Middleton Co., Inc., as follows:
