ORDINANCE NO. 76 - ORDINANCE OF TRANSFER OF APPROPRIATED GENERAL FUNDS AND PARK FUNDS.

SECTION I. BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its members being present and concurring therein that there exists an emergency for the transfer of certain appropriated General Funds, as follows:

From 10 B, Law Department Supplies
To 10 C, Law Department, Court Expense - - \$14.65

Section II. And that there now exists an emergency for transfer of certain appropriated Park Funds, as follows:

From 4-44, Park Dept Repairs to Drives and Tennis Courts
To 3-36, Park Dept Supplies and Repairs - - \$50.00

ORDINANCE NO: 76A

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED "AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE CITY OF LEBANON, INDIANA. BEGINNING January 1, 1960. "Passed by the common council August 31, 1959.

Filed - Salary Ordinance

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein, that:

SECTION 1: That Section one of the above entitled ordinance be amended by inserting therein between Sub-Section 'E' and Sub-Section 'F' a new Sub-Section called Sub-Section E-1 which shall read as follows:

Section 1:

E-1 That definition of Class I, II, and III policemen and firemen shall be as follows:

Class I: Any officer or firemen who has been on active duty for more than two(2) consecutive years and who has performed his duties as approved by his superior officer and the Board of Public Works of the City of Lebanon.

Class II: Any officer or fireman who has been on active duty for at least one(1) full year and who has performed his duties as approved by his superior officer and the Board of Public Works of the City of Lebanon.

Class III: Any officer or firemen who is on active duty within the probationary period of one(1) year.

FURTHER any officer or fireman may be disciplined by demotion to Second Class or Third Class for malfeasance of duty upon proper charges presented to and approved by his superior officer and the Board of Public Works of the City of Lebanon.
