AN ORDINANCE TO REPEAL AN ORDINANCE AND AMENDMENT THERETO ENTITLED,
 "An Ordinance regulating the erection, construction, enlargement, alteration, repair, moving, removal, demolition, conversion, occupancy, equipment, use, height, area, maintenance, electricity, plumbing, heating, ventilation, and air conditioning of all public and private buildings or structures in the City of Lebanon, Indiana: The creation of a building inspector; provisions for the issuance of permits and collection of fees therefor."
 PASSED BY THE COMMON COUNCIL ON THE 11th day of August, 1952 as Ordinance No. 8, and the Amendment thereto passed by the Common Council on the 27th day of October, 1958 as Ordinance No. 63.

Be it ordained by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein:

SECTION 1. That Ordinance No. 8, being the above entitled Ordinance and the Amendment to Ordinance No. 8, being Ordinance No. 63, are hereby repealed, repeal becoming effective February 18, 1960.

Passed by the Common Council of the City of Lebanon, Indiana, under suspension of the rules, and approved by me this 8th day of February, 1960, said Ordinance having been presented by Councilman Hardin.

AN ORDINANCE regulating the erection, construction, enlargement, alteration, repair, moving, removal, demolition, conversion, occupancy, equipment, use, height, area, maintenance, electricity, plumbing, heating, ventilation, and air conditioning of all public and private building or structures in the City of Lebanon, Indiana: The creation of a building inspector and salary therefor; provisions for the issuance of permits and collection of fees therefor.

BE it ordained by the Common Council of the City of Lebanon, Indiana:

SECTION 1. That certain documents, a copy of each of which are on file in the office of the City Clerk-Treasurer of the City of Lebanon, Indiana, being marked and designated as Volume 1 -- Building Rules and Regulations: Volume 2 -- Electrical
