WHEREAS, it is difficult to determine whether the sewer can be repaired by the City of Lebanon without some unforseen damage to the building, and,

WHEREAS, the Indemnitor desires and is in need of having said sewer repaired as soon as possible, it is the intent of this instrument and for the consideration herein contained that the Indemnitee be released from all responsibility and damage that may result in the repair of said sewer to the building, and,

WHEREAS, the Indemnitor does hereby agree to assume said responsibility resulting from the repair of said sewer to the building, and therefore agree to indemnify the Indemnitee by reason of said repair to said building, and,

WHEREAS, the Indemnitee agrees to use care in the repair of said sewer so as to mitigate as much damage to the building as possible.
