ORDINANCE NO. 90. AN ORDINANCE AMENDING EMERGENCY APPROPRIATION ORDINANCE NO. 89, PASSED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, JUNE 12, 1961.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its members being present and concurring therein.

SECTION 1. That the 1961 General Fund Budget for the City of Lebanon, Indiana be reduced in the amount of \$6000.00 by removing from said Budget under the Fire Department the appropriation for purchase or lease purchase of fire truck.

SECTION 2. That said ordinance shall be in full force and effect after its passage by the Common Council of the City of Lebanon, Indiana.

AGREEMENT

Filed Sanitary Landfill

THIS AGREEMENT made and entered into between the City of Lebanon, by its Mayor and the Town of Ulen, by the president of its Board of Trustees this 14th day of August, 1961 upon the following terms and conditions:

1. The Town of Ulen is hereby authorized to dispose of its refuse, trash and garbage at the dump site on the City's Farm on Road 52 North of said City; provided, however, that only Ira Scott or some person approved by the City of Lebanon shall be permitted to haul from said Town of Ulen; provided further that this authorization shall be confined to the present town limits of said Town of Ulen.
2. That in consideration for said authorization to dispose of its refuse, trash and garbage at said sump site, said Town of Ulen hereby agrees to pay the City of Lebanon the sum of \$240.00 per year.
3. This agreement shall be for the term of two (2) years from August 1, 1961.
