AGREEMENT

*Filed - garbage landfill*

THIS AGREEMENT made and entered into on the date hereinafter set out by and between the City of Lebanon, Indiana, hereinafter called the City and Town of Sheridan, Indiana, hereinafter after called the Town, upon the following terms and conditions, WITNESSETH:

1. The City hereby agrees to permit the Town to have access to and use the Sanitary Landfill owned and now being operated by the City on Road No. 52 four miles north of Lebanon, Indiana, the use by the Town to be for the purpose of disposing of the garbage collected by the Town from its residents only.

2. As consideration for the above and foregoing agreement on the part of the City, the Town hereby agrees to pay the sum of Three Hundred Seventy-Five (\$375.00) Dollars quarterly to the City. The Town further agrees to instruct its employees to dispose of its garbage at the direction of the operator of the Sanitary Landfill.

3. It is further agreed that this agreement shall be for a term of five (5) years and shall continue in effect unless one party notifies the other of its intention to cancel the same by giving the other party at least Ninety (90) days notice prior to the time that they wish to cancel.

4. That this agreement takes the place of another similar agreement between the parties and that it is the intent of the parties hereto that this agreement shall become effective on January 1, 1962.

IN WITNESS WHEREOF, the parties hereto have set their respective hands and seals this 27th day of December, 1961, The City by its Board of Works and The Town by its Town Board.

LEASE PURCHASE AGREEMENT

*Filed - Lease Agreement*

FOR GOOD AND VALUABLE CONSIDERATION, and upon the mutual promises hereinafter stated, it is hereby agreed by and between the O'BRIEN MANUFACTURING CORP. of Chicago, Illinois, hereinafter referred to as First Party, and CITY of LEBANON, INDIANA, hereinafter referred to as Second Party as follows:

1. That the First Party will lease to the Second Party for a period of one (1) year starting April 9, 1962 and ending April 9, 1963 the following described chattel commonly known as a sewer cleaning machine, together with the following described appurtenances:

The O'BRIEN POWER RODDER Model 1000 with 9 horsepower gasoline engine, 1000' of 3/8" high tensile rod, complete with 12 volt starter, generator and battery-mounted on a 1-1/2 ton F 500 1961 Ford Truck, specially equipped with Tool Boxes and special equipment for sewer rodding purposes.

2. That Second Party agrees to pay to the First Party for the use of said chattel and appurtenances above-described the sum of \$7,875.00, payable as follows: twelve (12) monthly payments of \$656.25 each, first payment to be made April 9, 1962, and a payment of \$656.25 to be made on the 9th day of each succeeding month until the entire sum is paid.

3. That Second Party shall have an option to purchase the above described chattel and appurtenances thereto for a total purchase price of \$7,875.00, exercisable by a written notice of exercise at any time prior to April 9, 1963. In the event of exercise of this option, all the payments made by Second Party under the provisions of Section 2 above shall be applied toward the principal balance. In the event of exercise of this option, title will be transferred to Second Party by First Party and Second Party will be liable for no further payments upon said chattel and shall be entitled to a bill of sale to said chattel and appurtenances thereto.

4. This machine has been delivered and serviced January 9, 1962.

5. This agreement shall be binding upon the parties hereto and <sup>their</sup> successors in interest and assigns.
