ORDINANCE NO. 5, 1962 - ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE CITY OF LEBANON, INDIANA BEGINNING JANUARY 1, 1963

Filed - Salary Ordinance

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its members being present and concurring therein:

SECTION 1 : That the salaries of the following employees of the City of Lebanon, Indiana, beginning January 1, 1963 be as follows:

A. Street Department

Salary of Commissioner - - - - - \$ 92.00 weekly
Salary of Laborers - - - - - 72.00 weekly

B. Garbage Department

Salary of Driver - - - - - 72.00 weekly
Salary of Assistants - - - - - 72.00 weekly
Salary of Bulldozer Operator - - - - - 53.00 weekly

(1) The above weekly rates to apply for a 40 hour week. However, when extreme emergencies arise requiring the above named employees to work more than 40 hours per week as intended, they shall be compensated at the following rates; Street Commissioner, \$2.30 per hour; laborers, \$1.80 per hour. Said overtime shall be allowed only during extreme emergencies occasioned by weather or other unusual conditions; such times to be at the discretion of the Mayor or the City Clerk-Treasurer of the City.

C. Park Department

Salary of Superintendent - - - - - 90.00 weekly
Salary of Assistant - - - - - 80.00 weekly
Salary of Laborer - - - - - 75.00 weekly
