

CONTRACT

This agreement made and entered into on the date hereinafter set out by and between the City of Lebanon and the Lebanon Utility Service Board, WITNESSETH:

WHEREAS, the City of Lebanon needs furniture and other equipment for the Fire Department, and,

WHEREAS, the City of Lebanon does not have the finances at the present time with which to purchase such equipment, and,

WHEREAS, said equipment is available through the Perkins Furniture Company of Lebanon for a total price of \$512.33 and said amount is allocated in the 1963 Civil City budget for said purpose and will be available in January 1963, and,

WHEREAS, the Lebanon Utility Service Board has funds available to purchase said equipment for and on behalf of the City of Lebanon, and,

It is therefore mutually agreed that the City of Lebanon accept the bid of the Perkins Furniture Company for said equipment and that the Lebanon Utility Service Board will pay the Seller said sum. That the City of Lebanon agrees to pay the sum of \$512.33 to the Lebanon Utility Service Board as early as possible in 1963 for said equipment.

ORDINANCE NO. 6 - AN EMERGENCY APPROPRIATION
ORDINANCE PROVIDING FOR
ADDITIONAL APPROPRIATIONS
FOR THE DEPARTMENTS NAMED
FOR THE YEAR 1962, AS RECOMMENDED
BY THE CLERK-TREASURER OF THE
CITY OF LEBANON, INDIANA

WHEREAS: Certain extraordinary conditions have developed since the adoption of the existing annual budget, so that it is now necessary to appropriate more money than was appropriated in the annual budget for the various functions of City Government, to meet such extraordinary emergencies:

SECTION 1. Be It Ordained By The Common Council of the City of Lebanon, Indiana, that for the expense of City Government the following sums of money are hereby appropriated and set apart out of the General Fund for the purposes herein specified, subject to the laws governing the same, such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law.

SECTION 2. That for said fiscal period there is hereby appropriated out of the General Fund, the following specified amounts to meet such extraordinary emergencies which are hereby declared to exist:
