ORDINANCE NO. 92, 1961 - ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE CITY OF LEBANON, INDIANA BEGINNING JANUARY 1, 1962.

Filed Ordinances Salaries

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its members being present and concurring therein:

SECTION 1: That the salaries of the following employees of the City of Lebanon, Indiana, beginning January 1, 1962 be as follows:

- A. Street Department
 - Salary of Commissioner (Maximum) - - - - - \$ 88.25 weekly
 - Salary of Laborers (Maximum) - - - - - 68.25 weekly
- B. Garbage Department
 - Salary of Driver (Maximum) - - - - - 68.75 weekly
 - Salary of Assistants (Maximum) - - - - - 68.25 weekly
 - Salary of Bulldozer Operator (Maximum) - - - - - 50.00 weekly
- C. Park Department
 - Salary of Superintendent (Maximum) - - - - - 80.00 weekly
 - Salary of Assistants (Maximum) - - - - - 75.00 weekly
- D. Police Department
 - Salary of Chief - - - - - 380.00 monthly
 - Salary of First Class Patrolmen - - - - - 330.00 monthly
 - Salary of Second Class Patrolmen - - - - - 320.00 monthly
