A resolution authorizing the alienation and conveyance of real property owned by the City of Lebanon to the Metropolitan School District of Lebanon, Boone County, Indiana.

WHEREAS, the City of Lebanon is the owner of the following described real estate, to-wit:

A part of the Southwest quarter of Section 30, Township 19 North, Range 1 East, being situated in Lebanon, Boone County, Indiana, and being more particularly described, as follows, to-wit:

From the Southwest corner of the aforesaid tract, proceed East with the Section line 516.78 feet to the center line of North East Street; thence North, with said centerline, 1176.70 feet; thence East, with the South line of Essex Drive, 810 feet to the Northeast corner of Lot #32, in Meadow Lane Addition to the City of Lebanon, Indiana. Thence continue Easterly, with the extended South line of Essex Drive, 543.59 feet; thence North 144.00 feet to the point of beginning.

From said point of beginning, proceed thence North 43.00 feet; thence East 47.25 feet; thence North 33.00 feet; thence East 181.75 feet/to the point of beginning, containing 0.189 Acres, more or less. thence South 76.00 feet; thence West 129.00 feet
