AGREEMENT

This agreement entered into and between the Board of Works of the City of Lebanon, Indiana, and the Metropolitan School District of Lebanon, Lebanon, Indiana, WITNESSETH:

WHEREAS, the Metropolitan School District of Lebanon desires to purchase the following described real estate from the City of Lebanon.

IT IS THEREFORE agreed that the City of Lebanon, by and through the Board of Public Works and Safety, agrees to sell and convey the following described real estate to the Metropolitan School District of Lebanon for the consideration of \$151.20 Dollars, to-wit:

A part of the Southwest quarter of Section 30, Township 19 North, Range 1 East, being situated in Lebanon, Boone County, Indiana, and being more particularly described, as follows, to-wit:

From the Southwest corner of the aforesaid tract, proceed East with the Section line 516.78 feet to the centerline of North East Street; Thence North, with said centerline, 1176.70 feet; thence East, with the South line of Essex Drive, 810 feet to the Northeast corner of Lot #32, in Meadow Lane Addition to the City of Lebanon, Indiana. Thence continue Easterly, with the extended South line of Essex Drive, 543.59 feet; thence North 144.00 feet to the point of beginning.

From said point of beginning, proceed thence North 43.00 feet; thence East 47.25 feet; thence North 33.00 feet; thence East 81.75 feet; thence South 76.00 feet; thence West 129.00 feet to the point of beginning, containing 0.189 acres, more or less.

It is therefore agreed by the parties to this agreement that said real estate above described shall be sold to the Metropolitan School District of Lebanon for the consideration of \$151.20 Dollars, the receipt of which is hereby acknowledged.

Subject to the Board of Works of the City of Lebanon and the School Board Trustees of the Metropolitan School District of Lebanon.

ORDINANCE NO. 16

AN ORDINANCE WITH REFERENCE TO TRAFFIC ON CERTAIN ALLEYS DESCRIBED HEREIN AND THE CREATION OF THE MOVING OF TRAFFIC ONE-WAY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Be it ordained by the Common Council of the City of Lebanon, Indiana, that on and after the passage of this ordinance,

SECTION I. That the alley extending from the west side of the public square in the City of Lebanon, Indiana, to North West Street shall be a one-way alley to traffic from North Lebanon Street to North West Street;

SECTION II. That the alley extending from the east side of the public square in the City of Lebanon, Indiana, to North East Street shall be a one-way alley to traffic from North Meridian Street to North East Street;

SECTION III. That the alley extending from the north side of the public square in the City of Lebanon, Indiana, to West North Street shall be a one-way alley to traffic from West Washington Street to West North Street;

SECTION IV. That the alley extending from the south side of the public square in the City of Lebanon, Indiana, to West South Street shall be a one-way alley to traffic from West Main Street to West South Street;

SECTION V. That the first alley south of West Main Street extending from South Lebanon Street to South West Street shall be a one-way alley to traffic from South Lebanon Street to South West Street.

That should any part of this ordinance be held invalid by a court of competent jurisdiction, the remaining parts shall be severable and shall continue to be in
