

WHEREAS: Certain extraordinary conditions have developed since the adoption of the adoption of the existing annual budget, so that it is now necessary to appropriate more money than was appropriated in the annual budget for the various functions of City Government, to meet such extraordinary emergencies:

SECTION 1. Be It Ordained By The Common Council of the City of Lebanon, Indiana, that for the expense of City Government of the following sums of money are hereby appropriated and set apart out of the General Fund for the purposes herein specified, subject to the laws governing the same, such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law.

SECTION 2. That for said fiscal period there is hereby appropriated out of the General Fund, the following specified amounts to meet such extraordinary emergencies which are hereby declared to exist:

ORDINANCE NO. 20

WHEREAS

AN ORDINANCE APPROVING A
CONTRACT WITH PUBLIC SERVICE
COMPANY OF INDIANA, INC.

WHEREAS: heretofore to-wit: On the 25th day of May, 1964, the city of Lebanon, by and through its Board of Public Works and Safety and its Lebanon Utility Service Board, entered into the following contract with Public Service Company of Indiana, Inc., to-wit:

AGREEMENT FOR SUPPLY OF TOTAL ELECTRIC REQUIREMENTS
OF A MUNICIPAL ELECTRIC DISTRIBUTING SYSTEM

THIS AGREEMENT made and entered into as of the 25th day of May, 1964, by and between PUBLIC SERVICE COMPANY OF INDIANA, INC, a corporation organized under the laws of the State of Indiana, (here inafter called "Company") and City of Lebanon, a municipal corporation organized under the laws of the State of Indiana (hereinafter called "Municipality"),

WITNESSETH:

That for and in consideration of the covenants and agreements herein contained, the parties do hereby covenant and agree as follows:

I. SERVICE TO BE FURNISHED

Subject to the terms and conditions hereinafter set forth, and the price hereinafter provided, Company shall furnish to Municipality, and Municipality shall take from Company, the entire requirements of electric energy for its own use and for resale to consumers residing in and in the vicinity of Lebanon,
