This agreement made and entered into on the date hereinafter set out by and between the City of Lebanon and the Lebanon Utility Service Board, WITNESSETH:

WHEREAS, the City of Lebanon is in dire need of purchasing a new Crawler Tractor to be used at the garbage land fill, and,

WHEREAS, the City of Lebanon has received bids for a Crawler Tractor and that the City of Lebanon has accepted the best bid to purchase a 1965 A. C. Crawler Tractor, HD6G for a Difference between the present tractor and the new tractor of \$9,995.00, and,

WHEREAS, the Lebanon Utility Service Board has funds available to purchase said tractor by paying the difference of \$9,995.00, and,

IT IS THEREFORE mutually agreed that the City of Lebanon accept the bid of \$9,995.00 for said tractor and that the Lebanon Utility Service Board shall pay said sum to the seller and that the City of Lebanon agrees herein to pay and reimburse the Lebanon Utility Service Board for said sum on or before December 31, 1965.
