

AGREEMENT FOR FIRE PROTECTION SERVICE CON'T

fire protection shall be in an amount equal to the tax levy for the year immediately preceding for the fire department and for the fireman's pension fund for Center Township, Boone County, Indiana, on each One Hundred (100.00) Dollars of the net assessed valuation of such incorporated Town, as such is reported by the Auditor of Boone County, Indiana, for tax purposes for the year immediately preceding. Each annual fee shall be payable on or before the 1st day of December of each year thereafter.

3. This agreement may be terminated by either party as of the 30th day of November, 1966, or as of November 30th of any subsequent year upon sixty (60) days written notice to the other party so to do, and which written notice should be served by the City upon the President of the Board of Trustees of said Town, and such written notice should be served by said Town upon the City Clerk of said City. If any such notice of termination is given by either party, a copy thereof shall be forwarded to the Indiana Rating Bureau of Indianapolis, Indiana.

4. This agreement is made and entered into pursuant to Ordinance No. 23 of said City entitled "An Ordinance Regulating the City of Lebanon Fire Department with regard to fire protection furnished incorporated Towns adjoining the City of Lebanon, fixing the charge for such fire protection, and repealing existing ordinances," and all the terms and provisions of said ordinance are to be considered a part of this agreement to the same extent as if copied herein in full.

IN WITNESS WHEREOF, said City has caused this agreement to be duly executed on its behalf by its Board of Public Works and Safety and said Town has caused the same to be duly executed on its behalf by its Board of Trustees, all on the day and year first above written.
