

approximately fourteen years from the date of issuance, for the purpose of providing funds to be used as above stated. Said bonds are to bear interest at a rate not to exceed $4\frac{1}{2}\%$ per annum, the exact rate to be determined by bidding. Objections to the issuance of said bonds may be made by ten or more taxpayers filing a petition in the office of the Auditor of Boone County within the time and in the manner provided by statute, which petition, if any, will be heard and considered by the State Board of Tax Commissioners in the manner provided by law.

The net assessed valuation of taxable property in the City of Lebanon, as shown by the last complete and final assessment for state and county taxes, is \$14,568,940.00, and the outstanding indebtedness of the City, exclusive of the above mentioned bonds and exclusive of revenue bonds is \$ -0-.

NOTICE OF ADDITIONAL APPROPRIATION
CITY OF LEBANON

Taxpayers of the City of Lebanon are hereby notified that the Common Council of said City did on the 11th day of July, 1966, consider on first reading Ordinance No. 30, which Ordinance provides for the appropriation of the sum of Two Hundred Eighty Thousand (\$280,000) Dollars to be applied for the cost of improvements and expansion of the existing storm water drainage system for Lebanon, Indiana, and for the construction, reconstruction and improvement of city bridges in the City of Lebanon, Indiana, together with the incidental expenses in connection therewith. Said appropriation is in addition to all existing appropriations provided for in the existing budgets, and the funds to meet the proposed appropriation are to be provided from the proceeds of the issuance of the bonds of the City in the amount of Two Hundred Eighty Thousand (\$280,000) Dollars.

Prior to final consideration of said Ordinance, a public hearing thereon will be held in the Council Chambers in the City Hall, at a meeting of the Common Council to be held on the 22nd day of August, 1966, at the hour of 7:30 P.M., at which time all taxpayers may appear and be heard on the question of the necessity for said additional appropriation.

If said additional appropriation is finally made, the same will be automatically referred to the State Board of Tax Commissioners, which Board will hold a further hearing within fifteen (15) days at the Office of Auditor of Boone County, or at such other place as may be designated. At such further hearing taxpayers objecting to said additional appropriation may be heard, and interested taxpayers may inquire of the County Auditor when and where such further hearing will be held.
